Terms & Conditions:

- Information on how to enter and claim the Manufacturers \$100, \$200 or \$300 Prepaid Card redemption offer form part of these Terms & Conditions. Participation in this promotion is deemed acceptance of these Terms & Conditions.

This Card is issued by Vii Pty Ltd ABN 83 619 963 263 ('we/us/our'). In these conditions 'you' are the Card purchaser or user. Vii Pty Limited ("Vii") is the issuer of the Card and authorises The Card Network ("TCN") Pty Ltd ABN 87 626 501 568 to distribute the Card. Using the Card, you agree to be bound by these Terms and Conditions [<https://www.eftpos.gift/termsandconditions>]. You must give these conditions to the user of the Card if that is not you. The Card remains our property.

This Card is an eftpos prepaid gift card that can be used for electronic transactions, to purchase goods and services. The Card will need to be activated once received. The card is valid from the date of activation. The relevant expiry period is printed on the back of your card and you can also check the remaining period of use and the card balance at <https://www.eftpos.gift/>.

12. The Promoter reserves the right, at any time, to verify the validity of claims (including contacting the place of purchase) and claimants (including a claimant's identity, age, and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms & Conditions or who tampers with the claim process.
